- (2) Any legal proceedings or application to any authority pending immediately before the commencement of this Act by or against the Institute in relation to the assets transferred to the Trust may be continued by or against the Trust.
- (3) After the commencement of this Act proceedings in respect of any right or obligation which was vested in, held, enjoyed, incurred or suffered by the Institute may be instituted by, or against the Trust.
- 7. (1) The Minister may, by statutory instrument, approve arrangements under which all or some of the employees of the Institute shall be transferred to the Trust.

Transfer of staff from the Institute

- (2) Where a person is transferred in accordance with the arrangements made under subsection (1), his terms and conditions with the Trust shall be no less favourable than those enjoyed while in the employment of the Institute, and for the purposes of determining his rights to or obligations for any pension, gratuity, leave or other benefits, his previous service with the Institute shall be treated as service with the Trust.
