An Act to amend the Ministerial and Parliamentary Offices (Emoluments) Act, 1992

[15th November, 1996

ENACTED by the Parliament of Zambia.

Enactment

1. (1) This Act may be cited as the Ministerial and Parliamentary Offices (Emoluments) (Amendment) Act, 1996, and shall be read as one with the Ministerial and Parliamentary Offices (Emoluments) Act, 1992, in this Act referred to as the principal Act.

(2) This Act shall be deemed to have come into operation on 1st April, 1996.

2. (1) The principal Act is amended by the repeal of section two A and the substitution therefor of the following:

2A. (1) There shall be paid to a member of the National Assembly a constituency allowance calculated—

Constituency
allowance

(a) in the case of a member returned by a constituency specified in Part I of the Third Schedule, at the annual rate specified in the second column of Part I of the Second Schedule; and

(b) in the case of a member returned by a constituency specified in Part II of the Third Schedule, at the annual rate specified in the third column of Part I of the Second Schedule;

(2) There shall be paid to a nominated member of the National Assembly in lieu of a constituency allowance, an allowance calculated at the annual rate specified in Part II of the Second Schedule.

Amendment
of section 4

3. Section *four* of the principal Act is amended by the deletion of subsection (1) and the substitution therefor of the following:

(1) Subject to the other provisions of this section, there shall be paid to the holder of an office specified in the First Schedule a gratuity at the rate of thirty-five per centum of his total emoluments:

Provided that any moneys paid to any holder of such office under the principal Act before the date of commencement of this Act shall be deducted from such gratuity.

4. The First and Second Schedules to the principal Act are hereby repealed and the First and Second Schedules set out in the Appendix are substituted therefor.
