# An Act to amend the Customs and Excise Act

[18th April, 1997]

ENACTED by the Parliament of Zambia.

1. (1) This Act may becited as the Customs and Excise (Arriendment) Act, 1997, and shall be read as one with the Customs and Excise Act, in this Act referred to as the principal Act.

(2) This Act shall be deemed to have come into operation on the 1st February, 1997.

2. Section *two* of the principal Act is amended by the insertion in the appropriate place of the following new definition:

" Assistant Commissioner " means the Assistant Commissioner of Customs and Excise;

**3.** Section *two hundred and one* of the principal Act is amended by the deletion of the proviso and the substitution therefor of the following proviso:

Provided that the duties and functions conferred or imposed by sections *one hundred and sixty-two* and *one hundred and sixty-eight* shall not be delegated to any officer below the rank of Assistant Commissioner.

4. The First Schedule to the principal Act is amended as set out in the First Appendix to this Act.

5. The Second Schedule to the principal Act is amended as set out in the Second Appendix to this Act.

6. The principal Act is amended by the repeal and replacement of the Third Schedule.
