An Act to amend the Constitutional Offices (Emoluments) Act

ENACTED by the Parliament of Zambia.

Enactment

1. (1) This Act may be cited as the Constitutional Offices (Emoluments) (Amendment) Act, 2002, and shall be read as one with the Constitutional Offices (Emoluments) Act, in this Act referred to as the principal Act.

- (2) This Act shall be deemed to have come into operation on the 1st April, 2002.
- 2. The principal Act is amended by the repeal of section two and the substitution therefor of the following:

(a) a salary at the annual rate prescribed for that office in the second column of the Schedule;
