**An Act to amend the Ministerial and Parliamentary
Offices (Emoluments) Act**

[24th November, 2008

ENACTED by the Parliament of Zambia.

1. (1) This Act may be cited as the Ministerial and Parliamentary Offices (Emoluments) (Amendment) Act, 2008, and shall be read as one with the Ministerial and Parliamentary Offices (Emoluments) Act, in this Act referred to as the principal Act.

5 (2) This Act shall be deemed to have come into operation on 1st January, 2008

2. The principal Act is amended by the repeal of the First Schedule and the substitution therefor of the First Schedule set out in Appendix I to this Act.

3. The principal Act is amended by the repeal of the Second Schedule and the substitution therefor of the Second Schedule set out in Appendix II to this Act.
