### An Act to amend the Road Traffic Act

[ 28th March, 2008

ENACTED by the Parliament of Zambia.

1. (1) This Act may be cited as the Road Traffic (Amendment) Act, 2008, and shall be read as one with the Road Traffic Act, 2002, in this Act referred to as the principal Act.

(2) This Act shall come into operation on 1st April, 2008.

2. The principal Act is amended by the repeal of the Second Schedule and the substitution therefor of the Second Schedule set out in the Appendix to this Act.
