The Zambia National Provident Fund Act
(Laws, Volume X, Cap. 513)

The Zambia National Provident Fund (Statutory Contributions) (Amendment) Regulations, 1980

IN EXERCISE of the powers contained in sections *sixteen A* and *eighteen* of the Zambia National Provident Fund Act, and after consultation with the Minister of Finance, the following Regulations are hereby made:

1. These Regulations may be cited as the Zambia National Provident Fund (Statutory Contributions) (Amendment) Regulations, 1980, and shall come into force on 1st April, 1980.

Title

2. A contributing employer shall, for every contribution period, pay into the Fund a statutory contribution in respect of each eligible employee employed by him during every such period at the rate prescribed for him in the Schedule hereto.

Statutory contributions

3. A contributing employer who is required to make a statutory contribution in respect of an employee may deduct the employee's share of such contribution from the wages due from him to that employee at the rate prescribed for him in the Schedule hereto.

Employee's share

4. Statutory Instrument No. 102 of 1973 is hereby revoked.
