## The Loans and Guarantees (Authorisation) (Exemption) Notice, 1983

IN EXERCISE of the powers contained in section fourteen of the Loans and Guarantees (Authorisation) Act, the following Notice is hereby issued:

1. This Notice may be cited as the Loans and Guarantees Title (Authorisation) (Exemption) Notice, 1983.

2. The Loans set out in the Schedule hereto, which have been guaranteed in terms of section fourteen of the Act, are hereby exempted from the payment of two per centum of the amount of the loan required under subsection (4) of the aforesaid section.
