The Loans and Guarantees (Authorisation) (Delegation of Functions) (No. 2) Order, 1985

IN EXERCISE of the powers contained in section twenty-seven of the Loans and Guarantees (Authorisation) Act, the following Order is hereby made:

1. This Order may be cited as the Loans and Guarantees (Authorisation) (Delegation of Functions) (No. 2) Order, 1985.

2. The functions of the Minister under the Act, in so far as such functions relate to the negotiation and signing of the proposed Loan Agreement described in the Schedule hereto and all other documents connected herewith, are hereby delegated to Sundie John Kazunga who is a public officer in the service of the Government of the Republic of Zambia and who is at present serving as Ambassador of the Republic of Zambia in Sweden and is stationed at Stockholm.

LOAN AGREEMENT

The Lean Agreement between the Danish Government (as Lenders) and the Government of the Republic of Zambia (as Borrowers) for an amount of about eighty-five million Danish Krones (D.Kr.85,000,000) which is about seventeen million thirty-eight thousand kwacha (17,038,000) to be signed some time in March or April, 1985, or soon thereafter.

 Deputy Director, Zambia National Provident Fund;
