## The Customs and Excise (Declaration of Approved Enterprises) Order, 1985

IN EXERCISE of the powers contained in section eighty-ninc of the Customs and Excise Act, as read with regulation 22 (2) of the Customs and Excise (Rebates, Refunds and Remissions) (General) Regulations, the following Order is hereby made:

1. (1) This Order may be cited as the Customs and Excise (Declaration of Approved Enterprises) Order, 1985.

Title and commencement

(2) This Order shall be deemed to have come into operation on the 25th January, 1985.

2. Each enterprise set out in the Schedule hereto is hereby declared to be an approved enterprise for the purposes of regulation 22 (2) of the Customs and Excise (Rebates, Refunds and Remissions) (General) Regulations, and shall, subject to the provisions of any other written law, remain an approved enterprise for a period of five years from the date on which it was so approved under the Industrial Development Act.


