The Roads and Road Traffic Act (Laws, Volume XV, Cap. 766)

The Roads and Road Traffic (Registration and Licensing) (Amendment) Regulations, 1988

IN EXERCISE of the powers contained in section two hundred and fifty-eight of the Roads and Road Traffic Act, the following Regulations are hereby made:

1. (1) These Regulations may be cited as the Roads and Road Traffic (Registration and Licensing) (Amendment) Regulations, 1988, and shall be read as one with the Roads and Road Traffic (Registration and Licensing) Regulations, in these Regulations referred to as the principal Regulations.
