The Tolls (Entry Fees) (Exemption)  
Regulations, 1988

IN EXERCISE of the powers contained in sections *eighteen* and *twenty-eight* of the Tolls Act, 1983, the following Regulations are hereby made:

1. These Regulations may be cited as the Tolls (Entry Fees) (Exemption) Regulations, 1988.

Title

2. The vehicles whose description appears in the Schedule hereto shall be exempt from the payment of the entry fees referred to in subsection (1) of section *eighteen* of the Act when entering Zambia at Nakonde and carrying bags of maize and beans from the Government of Kenya to the Government of the Republic of Zambia.
