(Laws, Volumes XIV, Cap. 707)

**The Trades Licensing (Revocation) (No. 3)
Order, 1988**

WHEREAS the President has, under Article 43 of the Constitution, authorised the Secretary-General of the Party, to discharge the powers of the President contained in section *twenty-four* of the Trades Licensing Act;

NOW THEREFORE, the following Order is hereby made:

1. This Order may be cited as the Trades Licensing (Revocation) (No. 3) Order, 1988. Title
2. All the licences under the Trades Licensing Act, held by the companies and persons named in the Schedule are revoked. Revocation of certain licences
