## The Town and Country Planning (Appointment of Planning Authorities) Regulations, 1989

IN EXERCISE of the powers contained in sections five and twenty-four of the Town and Country Planning, Act, the following Regulations are hereby made:

1. These Regulations may be cited as the Town and Titlo Country Planning (Appointment of Planning Authorities) Regulations, 1989.

2. (1) The authorities set out in the First Schedule are hereby appointed as the planning authorities for the respective areas described in that Schedule.

(2) The functions of the Minister under subsections (1) and (2) of section *twenty-five* of the Act relating to the grant or refusal of permission to develop or subdivide land are hereby delegated to the planning authorities set out in the Sohedule for the respective areas described in that Schedule.

3. (1) Except for the appointments made under section *five* of the Act, any other appointments of planning authorities made prior to the date hereof in respect of the areas described in the Schedule are hereby revoked.

(2) Except for the delegation of functions made under proviso (i) of subsection (1) of section *twenty-four* of the Act, any other delegation of functions made prior to the date hereof to any other planning authority in respect of the areas desoribed in the Schedule are hereby revoked.
