The Roads and Road Traffic Act (Laws, Volume XV, Cap. 766)

The Roads and Road Traffic (Registration and Licensing) (Amendment) Regulations, 1991

In exercise of the powers contained in section two hundred and fifty-eight of the Roads and Road Traffic Act, the following Regulations are hereby made:

1. (1) These Regultions may be cited as the Roads and Road Traffic (Registration and Licensing) (Amendment) Regulations, 1991, and shall be read as one with the Roads and Road Traffic (Registration and Licensing) Regulations, in these Regulations referred to as the principal Regulations.

- (2) These Regulations shall come into effect on the expiration of a period of thirty days after the date on which they are published in the Gazette.
- 2. The Second Schedule to the principal Regulations is revoled and the Second Schedule set out in the Appendix to these Regulations is substituted therefor.
