# The Immigration and Deportation (Amendment) Regulations, 1992

IN EXERCISE of the powers contained in section thirty-one of the immigration and Deportation Act, the following Regulations are hereby made:

1. These Regulations may be cited as the Immigration and Deportation (Amendment) Regulations, 1992, and shall be read as one with the Immigration and Deportation Regulations in these Regulations referred to as the principal Regulations.
