The Roads and Road Traffic (Public Service Vehicles, Licensing and Use) (Amendment) Regulations, 1992

IN EXERCISE of the powers contained in section two hundred and fifty-eight of the Roads and Road Traffic Act, the following Regulations are hereby made:

I. (1) These Regulations may be cited as the Roads and Road Traffic (Public Service Vehicles, Licensing and Use) (Amendment) Regulations, 1992, and shall be read as one with the Roads and Road Traffic (Public Service Vehicles, Licensing and Use) Regulations, in these Regulations referred to as the principal Regulations.

- (2) These Regulations shall come into effect on the expiration of a period of thirty days after the date on which they are published in the *Gazette*.
