The Income Tax (Foreign Organisations) (Approval and Exemption) (No. 2) Order, 1993

In exercise of the powers contained in section *fifteen* of the Income Tax Act, the following Order is hereby made:

- 1. This Order may be cited as the Income Tax (Foreign Organisations) (Approval and Exemption) (No. 2) Order, 1993.
- 2. With respect to the agreement described in the Sechedule to this Order Sheladia, Stanley and Burrow Joint Venture is hereby approved for the purpose of exemption from tax.

Approval of foreign organisation

Title

3. The income and emoluments of the foreign organisation approved in paragraph 2 of this Order accruingunder the agreement described in the Schedule to this Order shall be exempted from tax under sub-paragraph (c) of paragraph 4 of Part II of the Second Schedule to the Act.
