- 3. The principal Regulations are amended by the deletion of regulation 6 and the substitution thereof of the following:
 - 6. The members referred to in regulation 3 shall hold office for a period of three years from the date of appointment and may be re-appointed upon the expiration of that term.
- 4. The principal Regulations are amended by the deletion of regulation 22 and the substitution thereof of the following:
 - 22. A member of the Council or the Committee of the Council shall be paid such remuneration, allowances as the Council may with the approval of the Ministry determine.
