## The Customs and Excise (Remissions) (Zambia Railways Limited) Regulations, 1995

IN EXERCISE of the powers contained in section *eighty-nine* of the Customs and Excise Act, the following Regulations are hereby made:

1. These Regulations may be cited as the Customs and Excise (Remissions) (Zambia Railways Limited) Regulations, 1995.

Title

2. (1) The Commissioner shall remit the whole duty payable on the goods set out in the Schedule hereto, imported by Zambia Railways Limited, up to a value of forty-five million three hundred fifty-nine thousand, seven hundred and two United States Dollars.

Remmission of duty

2. The goods on which duty has been remitted under subregulation (1) shall not be sold or otherwise disposed of to any person not entitled to import them free of duty, except with the consent of the Commissioner and upon payment of duty, if any, at the rate leviable at the date of such sale or disposal.
