The High Court (Amendment) Rules, 1995

IN EXERCISE of the powers contained in section *forty-three* of the High Court Act, the following Rules are hereby made:

Title and commencement Cap. 50 p. 24

- 1. (1) These Rules may be cited as the High Court (Amendment) Rules, 1995, and shall be read as one with the High Court Rules, in these Rules referred to as the principal Rules.
 - (2) These Rules shall come into operation on 14th April, 1995.
- 2. The principal Rules are amended in order 1 by the revocation of rule 5 and the substitution therefor of the following:

" 5. The court fees or any other fees payable under these Rules shall be paid by cash, postal order, or bank certified cheque. Mode of payment of fees

3. The principal Rules are amended by the revocation of the Second Schedule and the substitution therefor of the Second Schedule set out in the Appendix.
