**The Energy Regulation (Licensing) Regulations, 1998**

IN EXERCISE of the powers contained in sections *nine* and *ten* of the Energy Regulation Act, the following Regulations are hereby made:

| 2. In these Regulations unless the context otherwise requires, "application" means an application for a licence pursuant to section <i>nine</i> of the Act.  | Interpretation                                |

(1) An application for a licence to operate an undertaking shall be in the form set out in Part I of the First Schedule and shall contain the particulars described therein.<br><br>(2) An application form under these Regulations—<br><br>(a) shall be submitted to the Board in triplicate;<br><br>(b) shall be accompanied by the application fee as set out in the Second Schedule; and<br><br>(c) shall be accompanied by the documents and particulars specified in Part II of the First Schedule. | Form of application                           |
| 4. The Board may require, from any person who has lodged an application for a licence under these Regulations, such further information as it considers necessary.   | Requirement of further information            |
| 5. The Gazette notice to be published by the Board in accordance with subsection (4) of section <i>nine</i> shall, in addition to the matters specified in that subsection—<br><br>(a) specify the full names of the current directors of the applicant identifying their residential addresses, nationality and other affiliations and background including   | Additional matters for publication in Gazette |

full disclosure of an interest in any other licensed undertaking engaged in the energy sector in Zambia;

(b) describe the extent to which the applicant considers it necessary to seek compulsory acquisition of land or rights over land; and

(c) specify the date when the proposed undertaking is expected to be commissioned.

Inspection of applications

6. Any person may inspect an application for a licence or request the Board to furnish that person with a copy of an application under these Regulations on payment of the fee set out in the Second Schedule.

Form of objections to application for licence

7. Any objection lodged in accordance with section ten of the Act shall be in form set out in the Third Schedule to these Regulations.
