The Local Government (Appointment of Local Government Administrator) (Samfya District Council) Order, 1998

IN EXERCISE of the powers contained in section eighty-eight of the Local Government Act, the following Order is hereby made:

1. This Order may be cited as the Local Government (Appointment of Local Government Administrator) (Samfya District Council) Order, 1998.

Title

2. The person named in the Schedule, being a public officer in accordance with paragraph (a) of section eighty-eight of the Local Government Act, is hereby appointed Local Government Administrator for Samfya District Council.

3. The person appointed Local Government Administrator under paragraph 2 shall discharge all the functions of the Samfya District Council.

4. The Samfya District Council shall stand suspended from the date of publication of this Order.

The Roads and Road Traffic Act (Laws, Volume 26, Cap. 464)

The Roads and Road Traffic (Driving Licence)
(Amendment) Regulations, 1998

IN EXERCISE of the powers contained in section two hundred and fifty-eight of the Roads and Road Traffic Act, the following Regulations are hereby made:

1. (1) These Regulations may be cited as the Rouds and Road Traffic (Driving Licence) (Amendment) Regulations, 1998, and shall be read as one with the Roads and Road Traffic (Driving Licence) Regulations hereinafter referred to as the principal Regulations.

- (2) These Regulations shall come into effect on the expiration of a period of *thirty* days after the date on which they are published in the *Gazette*.
- 2. The First Schedule to the principal Regulations is hereby revoked and the Schedule set out in the appendix to these Regulations is substituted therefor.

FIRST SCHEDULE (Regulation 11)

Code	Classes of Motor Vehicle
Α	Motor cycles
Al	Motor cycles of engine capacity of less than or equal to 500 cc
A2	Motor cycles of engine capacity of less than or equal to 125 cc
В	Private motor vehicles of weight not more than 350 Kg but above 750 GVM
CI	Motor vehicles of weight exceeding 16000 Kg GVM
C	Heavy goods vehicles. Private omnibus of less than or equal to 16000 GVM
EB	Private motor vehicles drawing trailer other than a light trailer or caravan which is not included in any class
