The Mumbwa District Council (Maize Levy) (Amendment) By-laws, 1998

IN EXERCISE of the powers contained in sections sixty-nine and seventy-six of the Local Government Act, the following By-laws are hereby made:

These By-laws maybe cited as the Mumbwa District Council (Maize Levy) (Amendment) By-laws, 1998 and shall be read as one with the Mumbwa District Council (Maize Levy) By-laws, 1995, in these By-laws referred to as the principal By-laws.

Title

S.I. No. 19 of 1995

The principal By-laws are amended by the revocation of bylaw 5 and the substitution therefor of the following:

Revocation and replacement of by-law 5

5. Any person who contravenes any of the provisions of Offences and these By-laws shall be guilty of an offence and shall be liable, penalties upon conviction—

- (a) in the case of a first offence, to a fine not exceeding sixty penalty units or to imprisonment for a period not exceeding six months, or to both; and
- (b) in the case of a second or subsequent offence, to a fine not exceeding sixteen penalty units for every day during which the offence continues or to imprisonment not exceeding six months orto both.

Offences and penalties

- 6. A person who contravenes any of the provisions of these By-laws shall be guilty of an offence and shall be liable upon conviction—
 - (a) in the case of a first offence, to a fine not exceeding six penalty units or to imprisonment for a period not exceeding three months, or to both; and
 - (b) in the case of a second or subsequent offence, to a fine not exceeding eleven penalty units for every day during which the contravention continues or to imprisonment not exceeding six months, or to both.
