# The Local Government Act (Laws, Volume XVI, Cap. 281)

### The Local Government (Appointment of Local Government Administrator) (Chadiza District Council) Order, 1998

IN EXERCISE of the powers contained in section *eighty-eight* of the Local Government Act, the following Order is hereby made:

I. This Order may be cited as the Local Government Title (Appointment of Local Government Administrator) (Chadiza District Council) Order, 1998.

2. The person named in the Schedule, being a public officer in accordance with paragraph (a) of section *eighty-eight* of the Local Government Act, is hereby appointed Local Government Administrator for Chadiza District Council.
