The Zambia National Tender Board Act (Laws, Volume 22, Cap. 394)

The Tender (Amendment) Regulations, 1998

IN EXERCISE of the powers/contained in section *twenty-seven* and on the recommendation of the Board, the following Regulations are hereby made:

1. These Regulations's may be cited as the Tender (Amendment) Regulations 1998, and shall be read as one with the Tender Regulations, in these Regulations referred to as the principal Regulations.

2. Regulation 24 of the principal Regulations is amended in subsection (1) by the deletion of paragraphs (c), (d) and (e) and the substitution therefor of the following:

- (c) exceeds two million kwacha but does not exceed five million kwacha, informal tenders shall be invited, examined and where appropriate authorised for acceptance by the Controlling Officer;
- (d) exceeds five million kwacha but does not exceed fifteen million kwacha informal tenders shall be invited, examined and where appropriate, authorised for acceptance by the Ministry or Provincial Tender Committee;
- (e) exceeds fifteen million kwacha but does not exceed twentyfive million kwacha, informal tenders shall be invited, examined and where appropriate. authorised by the Central Tender Committee; and
- (f) exceeds twenty-five million kwacha, formal tenders shall be invited, examined and where appropriate authorised for acceptance by the Zambia National Tender Board.
