# - The Value Added Tax Act (Laws, Volume 19, Cap. 331)

## The Value Added Tax (Taxable Value) (Amendment) Regulations, 1998

IN EXERCISE of the powers contained in section *two* of the Value<sup>-</sup> Added Tax Act, the following Regulations are hereby made:

1. (1) These Regulations may be cited as the Value Added Tax (Taxable Value) (Amendment) Regulations, 1998, and shall be read as one with the Value Added Tax (Taxable Value) Regulations, 1997, in these Regulations referred to as the principal Regulations.

Title and commencement S.I. No. 40 of 1997

(2) These Regulations shall come into force on 27th March, 1998.

2. The principal Regulations are amended by the revocation of the Second Schedule and the substitution therefor of the Second Schedule set out in the Appendix to these Regulations.
