| 2. Nominations for the election of a councillor in every ward of a council set out in the Schedule to this Order may be lodged with the returning Officer on Tuesday, 25th June, 2002, between 0900 hours and 1500 hours. | Nomination for election |
| 3. The poll for the election of a councillor in every ward of a council set out in the Schedule to this Order shall be taken on Tuesday, 9th July, 2002, between 0600 hours and 1700 hours. | Election dates and times of poll |
| 4. A poll shall not be taken in a ward in which only one candidate is validly nominated for the election. | Nomination of candidate |
