| 1. This Order may be cited as the Control of Goods (Import and Export) (Prohibition of Imports) Order, 2002.  | Title                            |
| 2. No person shall import into the Republic of Zambia from the Republic of Zimbabwe the goods set out in the Schedule to this Order.  | Prohibition of specified imports |
| 3. Any person who contravenes the provisions of this Order commits an offence and is liable upon conviction to a fine not exceeding fifteen thousand penalty units or to imprisonment for a period not exceeding four months, or to both; and on conviction for a second or subsequent offence, to a fine not exceeding sixty thousand penalty units or to imprisonment for a period not exceeding six months or to both. | Offences and penalties           |
