The Companies (Fees) (Amendment) Regulations, 2005

IN EXERCISE of the powers contained in section *four hundred* of the Companies Act, the following Order is hereby made:

1. These Regulations may be cited as the Companies (Fees) (Amendment) Regulations, 2005 and shall be read as one with the Companies (Fees) Regulations, 1998, in these Regulations referred to as the principal Regulations.

2. The principal Regulations are amended by the revocation of the Schedule and the substitution therefor of the schedule set out in the Appendix to these Regulations.
