The National Council for Construction (Forms and Fees) **Regulations**, 2005

IN EXERCISE of the powers contained in section twenty-seven of the National Council for Contruction Act, 2003 the following Regulations are hereby made:

1. These Regulations may be cited as the National Council for Title Construction (Forms and Fees) Regulations, 2005.

2. The form set out in the First Schedule shall be the prescribed form for the purposes of section seven of the Act.

3. The fees set out in the second Schedule shall be the prescribed fees for the matters mentioned therein.


