The Zambia Police (Fees) Regulations, 2006 IN EXERCISE of the powers contained in section sixty-two of the Zambia Police Act, the following Regulations are hereby made: 1. These Regulations may be cited as the Zambia Police (Fees) Title Regulations, 2006. 2. A person requiring Police Clearance or any other service to be Fees for police clcarance and processed shall pay the full cost of that service as prescribed in the other services Schedule. 3.
