## The National Forest No. 16 Njiri (Cessation) Order, 2007.

IN EXERCISE of the powers contained in section eight of the Forests Act, the following Order is hereby made:

This Order may be cited as the National Forest No.16 Njiri 1. Title

(Cessation) Order, 2007.

2. The area described as Forest Reserve No. 16, Njiri in Statutory Instrument No. 46 of 1964 and declared as National Forest No. 16 njiri in the First Schedule to the National Forests (Declaration) Order, 1975, shall ccase to be a National forest from the date of the publication of this Order.

## **SCHEDULE**

(Paragraph 2)

NATIONAL FOREST NO. F 16, NJIRI

Starting at beacon W415 at the southwestern corner of Mineral Area 435m, the boundary proceeds southeastwards along the southwesterly boundary of this area to beacon ID301; thence southwestwards to the northerly corner of Farm 2840 on the Mutundu stream near beacon ID305; thence southwards down the east bank of the Mutundu stream to the point where it crosses the northeasterly boundary of Mineral Area 431m near beacon W400; thence northwestwards along the northeasterly boundaries of Mineral Areas 431m and 131m, through beacon W390 to beacon W389; thence northeastwards to beacon VG47 at the southern corner of Farm 3013; thence along the southeasterly boundary of this Farm to beacon VG46; thence northwestwards along its northeasterly boundary to the southeasterly of Farm 2564; thence northeastwards along this boundary to the most easterly corner of this Farm near beacon HT1071; thence northeastwards to the point of intersection of the lines which are parallel to and 30 metres southwest and southeast respectively of the southwestern and
