The National Forest No. F 8, Ichimpe (Alteration of Boundaries) Order, 2007

In Exercise of the powers contained in Section *eight* of the Forests Act, the following Order is hereby made:

- 1. This Order may be cited as the National Forest No. F 8, Ichimpe (Alteration of Boundaries) Order, 2007.
- 2. The Boundaries of National Forest No. F 8, Ichimpe shall be altered by the deletion of existing boundary description thereof and the substitution therefor of the description set out in the Schedule to this Order.
