The Customs Act (Laws, Volume 18, Cap. 322)

The Customs and Excise (Ports of Entry and Routes) (Amendment) Order, 2008

IN EXERCISE of the powers contained in section thirteen and one hundred and ninety nine of the Customs and Excise Act, the following Order is hereby made:

This Order may be cited as the Customs and Excise (Ports 1. of Entry and Routes)(Amendment) Order, 2008, and shall be read as one with the Customs and Excise (Ports of Entry and Routes) Order, 2003, in this Order referred to as the principal Order.

2. Paragraph 11 of the principal Order is amended in the proviso by the insertion after paragraph (b) of the following new paragraph:

(c) at Lusaka Airport-

- (i) bills of entry may be received on all weekdays including Saturdays from 08:30 hours to 13:00 only; and
- (ii) for the transaction of other business from 08:30 hours to 13:00 hours and from 14:00 to 17:00 hours on weekdays and 08:30 to 13:00 hours on Saturdays.

3. The First Schedule to the principal Order is amended in Amendment Part I and Part II by the insertion in the appropriate place of the port of entry and the port of exportation of goods, set out in Appendix I to this Order.

4. The Fifth Schedule to the principal Order is amended in Part I by the insertion in the appropriate place of the general post set out in Appendix II to this Order.

The Seventh Schedule to the principal Order is amended by 5. the insertion in the appropriate place of the customs port set out in Appendix III to this Order.
