## The Local Forest No. P 54: West Mvuvye (Declaration) Order, 2009

IN EXERCISE of the powers contained in section Seventeen and sixty-eight of the Forests Act, the following Order is hereby made:

1. This Order may be cited as the Local Forest No. P. 54: Title West Mvuvye(Declaration) Order, 2009.

2. The area described in the Schedule to this Order is hereby Declaration of declared Local Forest No. P 54: West Mvuvye.

## SCHEDULE

(Paragraph 2)

LOCAL FOREST NO. P. 54 WEST MVUVYE

Starting at the confluence of the Mvuvye and Mtirizi Rivers, the boundary follows the left bank of the latter upstream to its confluence with Katuwa Stream; thence up the left bank of the Katuwa to a forest beacon at its source; thence on a bearing of 232 degrees for 18,300 feet; thence in a straightline to beacon NRP22 on Chipirinyuma Hill; thence on a bearing of 320 degrees for 19,000 feet. thence on a bearing of 325 degrees to the source of the Nyamadzi Stream; thence down the right bank of this stream to a forest beacon situated east of the source of the Kalambola Stream on a bearing 108 degrees from that source; thence on the source of the Kalaubola Stream and continuing down its right bank to its confluence with the Luangwa River; thence up the left of the river to its confluence with the Mvuvye River; thence up the left bank of the latter to a forest beacon at the foot of the Kambala Hill ridge; thence in a general south-westerly direction along the top of this ridge to a forest beacon on the Chinanga Stream; thence up the left bank of this stream to a forest at its source; thence south-east wards in a straight line to af orest beacon at the source of the Nyakamba Stream; thence down the right bank of this stream to a forest beacon near its confluence with the Lupezi Stream;

thence south-eastwards in a straight line to the confluence of the Mvuvye and Mtirizi Rivers, the point of starting.

Included with the Forest Reserve but not within the above described boundaries are the eastern, southern and western slopes of the Chipirinyuma Hill.

The above described area, in extent 62, 125 hectares approximately is shown bordered green on Plan No. F.R. 102/1 deposited in the office of the Surveyor-General, signed by him and dated 10th January, 2008.
