The Zambia Development Agency (Sub-Sahara Gemstone Exchange Industrial Park) (Declaration) Order, 2010

IN EXERCISE of the powers contained in section eighteen of the Zambia Development Agency Act, 2006, and on the recommendation of the Board, after consultation with the Minister responsible for finance and with the approval of the Cabinet, the following Order is hereby made:

1. This Order may be cited as the Zambia Development Agency (Sub-Sahara Gemstone Exchange Industrial Park) (Declaration) Order, 2010.

Title

- 2. In this Order, "industrial park" means the Sub-Sahara Gemstone Exchange Industrial Park.
- Interpretation
- 3. The area, comprising the pieces of land described in the First Schedule to this Order, is hereby declared as the Sub-Sahara Gemstone Exchange Industrial Park.

Declaration of Sub-Sahara Gemstone Exchange Industrial Park

4. (1) The licensee specified in the Second Schedule to this Order shall provide, within the industrial park, infrastructure and facilities which are suitable for the operation of the industries specified in subparagraph (2) and which shall include—

Facilities to be provided by licensee in industrial park

- (a) buildings;
- (b) electricity;
- (c) telecommunication facilities;
- (d) water and waste disposal facilities; and
- (e) roads.
- (2) The infrastructure and facilities referred to in subparagraph
- (1) shall be such as are suitable for the operation of-

- (a) lapidaries and gemstone processing industries;
- (b) light engineering industries;
- (c) construction and hardware industries;
- (d) electrical appliance industries;
- (e) food industries;
- (f) clothing industries; and
- (g) copper processing industries.

Sales of goods produced in industrial park 5. The goods produced or services provided in the industrial park may be sold, exported or otherwise disposed of in the ordinary course of business.

2. In this Order, "multi-facility economic zone" means the Lusaka East Multi-Facility Economic Zone.

Interpretation

3. The area, comprising the piece of land described in the First Schedule to this Order, is hereby declared as the Lusaka East Multi-Facility Economic Zone.

Declaration of Lusaka East Multi-Facility Economic Zone

4. (1) The licensee specified in the Second Schedule to this Order shall provide, within the multi-facility economic zone, infrastructure and facilities which are suitable for the operation of the industries specified in subparagraph (2) and which shall include—

Facilities to be provided by licensee in multifacility zone

- (a) buildings;
- (b) electricity;
- (c) telecommunication facilities;
- (d) water and waste disposal facilities; and
- (e) roads.
