The Ministerial and Parliamentary Offices Emoluments (Amendment) Regulations, 2012

IN EXERCISE of the powers contained in section *two* of the Ministerial and Parliamentary Offices (Emoluments) Act, and after consultation with the Standing Orders Committee of the National Assembly, the following Regulations are hereby made:

1. (1) These Regulations may be cited as the Ministerial and Parliamentary Offices (Emoluments) (Amendment) Regulations, 2012, and shall be read as one with the Ministerial and Parliamentary Offices (Emoluments) Regulations, 2009, in these Regulations referred to as the principal Regulations.

Title and commencement S. I. No. 62 of 2009

- (2) These Regulations shall come into operation on 1st April, 2012
- 2. The principal Regulations are amended by the repeal of the First Schedule and the substitution therefor of the First Schedule set out in Appendix 1 to these Regulations.

3. The principal Regulations are amended by the repeal of the Second Schedule and the substitution therefor of the Second Schedule set out in Appendix II to these Regulations.
