The National Assembly By-Elections (Livingstone Constituency No. 123, Chama North Constituency No. 039 and Muchinga Constituency No. 013) (Election Dates and Times of Poll Order, 2012

WHEREAS in pursuance of regulation 7 of the Electoral (General) Regulations, 2006, the Speaker of the National Assembly has informed the President and the Electoral Commission of the vacancy in respect of the Livingstone Constituency No. 123 by reason of the nullification of the Livingstone Constituency Parliamentary Election by the Livingstone High Court on 13th March, 2012, in respect of the Chama North Constituency No. 039, by reason of nullification of the Chama North Constituency Parliamentary Election by the Lusaka High Court on 2nd April, 2012, and in respect of the Muchinga Constituency, by reason of the death of Mr George Kunda, sc, MP, on 16th April, 2012.

Now THEREFORE, in exercise of the powers contained in regulation 8 of the Electoral (General) Regulations, 2006, the following Order is hereby made:

1. This Order may be cited as the National Assembly By-Elections Title (Livingstone Constituency No. 123, Chama North Constituency No. 039 and Muchinga Constituency No. 013) (Election Dates and Times of Poll) Order, 2012.

Nomination for National Assembly by-election in Livingstone 2. Constituency No. 123, Chama North Constituency No. 039 and Muchinga Constituency No. 013 shall be lodged with the Returning Officer on Thursday, 7th June, 2012, between 0900 hours and 1500 hours.
