Order, 2013**

WHEREAS in pursuance of regulation 7 of the Electoral (General) Regulations, 2006, the Speaker of the National Assembly has informed the President and the Electoral Commission of the vacancies in respect of the Mkushi North Constituency No. 07, by reason of the resignation of Mr. Knorrasco Musonda Mutale as Member of Parliament for Mkushi North Constituency, in respect of the Kafulafuta Constituency No. 029 by reason of the resignation of Mr. James Chishaba as Member of Parliament for Kafulafuta Constituency, in respect of the Solwezi East Constituency No. 111 by reason of the resignation of Mr. Richard Taima as Member of Parliament for Solwezi East Constituency and in respect of the Chipata Central Constituency No. 042 by reason of the nullification by the Supreme Court on 7<sup>th</sup> May, 2013, of the election of Mr. Rueben Phiri Mtolo as Member of Parliament for Chipata Central Constituency;

NOW THEREFORE, in exercise of the powers contained in regulation 8 of the Electoral (General) Regulations, 2006, the following Order is hereby made:

1. This Order may be cited as the National Assembly (Mkushi North Constituency No. 07, Kafulafuta Constituency No. 029, Solwezi East Constituency No. 111 and Chipata Central Constituency No. 042) (Election Dates and Times of Poll) Order, 2013. Title

Nomination for election 2. Nomination for National Assembly by-election in Mkushi North Constituency No. 07, Kafulafuta Constituency No. 029, Solwezi East Constituency No. 111 and Chipata Central Constituency No. 042 shall be lodged with the Returning Officer on Thursday, 27th June, 2013, between 0900 hours and 1500 hours.

Campaign period 3. The campaign periods in the constituencies referred to in paragraph 2 shall commence on Thursday, 27<sup>th</sup> June, 2013, at 1500 hours and close at 1800 hours on Wednesday, 24<sup>th</sup> July, 2013.

Times of poll 4. The polls in the constituencies referred to in paragraph 2 shall be taken on Thursday, 25<sup>th</sup> July, 2013 between 0600 hours and 1800 hours, except that a poll shall not be taken in the constituency if only one candidate is validly nominated for the election.
