WHEREAS in pursuance of regulation 7 of the Electoral (General) Regulations, 2006, the Speaker of the National Assembly has informed the President and the Electoral Commission of Zambia of the vacancy in respect of the Kasenengwa Constituency No. 43, Mkushi South Constituency No. 8, SolweziCentral Constituency No. 110, Vubwi Constituency No. 38 and Zambezi West Constituency No. 114 by reason of the nullification of the Kasenengwa Constituency No. 43, Mkushi South Constituency No. 8, Solwezi Central Constituency No. 110, Vubwi Constituency No. 38 and Zambezi West Constituency No. 114 of the National Assembly Elections by the Supreme Court;

AND WHEREAS the Supreme Court, on 3rd July, 2014, decided the motions concerning the constituencies;

Now THEREFORE, in exercise of the powers contained in regulation 8 of the Electoral (General) Regulations, 2006, the following Order is hereby made:

1. This Order may be cited as the National Assembly By-Elections (Kasenengwa Constituency No. 43, Mkushi South Constituency No. 8, Solwezi Central Constituency No. 110, Vubwi Constituency No. 38 and Zambezi West Constituency No. 114) (Election Dates and Times of Poll) Order, 2014.

Nomination for election	2. Nomination for the National Assembly by-election in the Kasenengwa Constituency No. 43, Mkushi South Constituency No. 8, Solwezi Central Constituency No. 110, Vubwi Constituency No. 38 and Zambezi West Constituency No. 114 shall be lodged with the Returning Officer on Tuesday, 12th August, 2014, between 0900 hours and 1500 hours.
Campaign period	3. The campaign period in the constituencies referred to in paragraph 2 shall commence on Tuesday, 12th August, 2014, at 1500 hours and close at 1800 hours on Wednesday, 10th September, 2014.
Times of	4. The poll in the constituencies referred to in paragraph 2

4. The poll in the constituencies referred to in paragraph 2 shall be taken on Thursday, 11th September, 2014, between 0600 hours and 1800 hours, except that the poll shall not be taken in a constituency if only one candidate is validly nominated for the election.
