# The Customs and Excise (Ports of Entry and Routes) (Amendment) Order, 2014

In exercise of the powers contained in sections *thirteen* and *one hundred* and *ninety-nine* of the Customs and Excise Act, the following Order is hereby made:

1. This Order may be cited as the Customs and Excise (Ports of Entry and Routes) (Amendment) Order, 2014, and shall be read as one with the Customs and Excise (Ports of Entry and Routes) Order, 2003, in this Order referred to as the principal Order.

- 2. Paragraph 11 of the principal Order is amended by the deletion of the proviso and the substitution therefor of the following: Provided thatô
  - (a) at Chanida, Kariba, Kasumbalesa, Katima Mulilo, Kazungula and Mwami, business shall be transacted at all hours of the day, on all days including Saturdays, Sundays and public holidays;
  - (b) at Kapiri Mposhi and Livingstone, business shall be transacted from 08.30 hours to 13.00 hours and from 14.00 hours to 17.00 hours on weekdays only, and 08.30 hours to 13.00 hours on Saturdays, Sundays and public holidays;
  - (c) at Chirundu, bills of entry may be received from 06:00 hours to 22:00 hours on all days including Saturdays, Sundays and public holidays;
  - (d) at Nakonde, bills of entry may be received at all hours of the day and night on all days including Saturdays, Sundays and public holidays; and
  - (e) at Lusaka airportô
    - (i) bills of entry may be received on all weekdays including Saturdays from 08:30 hours to 1300 hours only; and

(ii) business shall be transacted from 08:30 hours to 13:00 hours and from 14:00 hours to 17:00 hours on weekdays, and 08:30 hours to 13:00 hours on Saturday.
