# The Customs and Excise (Suspension) (Fuel) (No. 2) Regulations, 2016

IN EXERCISE of the powers contained in section *eighty-nine* of the Customs and Excise Act, the following Regulations are made:

1. (1) These Regulations may be cited as the Customs and Excise (Suspension) (Fuel) Regulations, 2016.

Title and commencement

- (2) These Regulations are deemed to have come into effect on 2nd March, 2016 and shall cease to have effect on 31st August, 2016.
- 2. The customs duty on petrol of heading 2710.12.10 and diesel of heading 2710.19.10 shall be suspended to zero percent where the oil marketing companies specified in the Schedule import the quantities of petrol or diesel for filling stations as specified in the Schedule.
