# The Legal Practitioners (High Court) (Fixed Costs) Order, 2016

In EXERCISE of the powers contained in section *seventy* of the Legal Practitioners Act, and on the recommendation of the Remuneration Committee, the following Order is made:

- 1. This Order may be cited as the Legal Practitioners (High Title Court) (Fixed Costs) Order, 2016.
- 2. Where costs are allowed in proceedings in the High Court, the costs shall be taxed at the fixed rates set out in the Schedule.
