| <p>2. (1) The principal Order is amended by the insertion of the following new paragraph immediately after paragraph 9:</p> <p style="padding-left: 40px;">9A. (1) The goods specified in the Seventh Schedule shall only be exported through the customs ports and aerodromes set out in the Eighth Schedule.</p> <p style="padding-left: 40px;">(2) A person shall not, without the permission of the Commissioner-General, divert any of the goods specified in the Seventh Schedule to be exported through a customs port and aerodrome than the one set out in the Eighth Schedule.</p> <p style="padding-left: 40px;">(3) Goods exported through Victoria Falls port in accordance with this paragraph shall be transported by rail.</p> | <p>Insertion of

The hours for the transaction of business at customs houses shall—</p> <p style="padding-left: 40px;">(a) be from 08:00 hours to 13:00 hours and 14:00 hours to 17:00 hours on weekdays;</p> <p style="padding-left: 40px;">(b) despite paragraph (a)—</p> <p style="padding-left: 80px;">(i) at Chanida, Kariba, Kasumbalesa, Katima Mililo, Kazungula and Mwami, business shall be transacted at all hours of the day, on all days including Saturdays, Sundays and public holidays;</p> | <p>Revocation

- (ii) at Kapiri-Mposhi and Livingstone, business shall be transacted from 08:30 hours to 13:00 hours and from 14:00 hours to 17:00 hours on weekdays and 08:30 hours to 13:00 hours on Saturdays, Sundays and public holidays;
- (iii) at Chirundu, bills of entry may be received and business transacted all hours of the day and night on all days including Saturdays, Sundays and public holidays;
- (iv) at Nakonde, bills of entry may be received at all hours of the day and night on all days including Saturdays, Sundays and public holidays; and
- (v) at Lusaka airport —
 - (aa) bills of entry may be received on all weekdays including Saturdays from 08:00 hours to 13:00 hours; and
 - (bb) business shall be transacted from 08:30 hours to 13:00 hours and from 14:00 hours to 17:00 hours on weekdays and 08:30 hours to 13:00 hours on Saturday.
