The Immigration and Deportation (General)
(Amendment) Regulations, 2020

IN EXERCISE of the powers contained in section 59 of the Immigration and Deportation Act, 2010, the following Regulations are made:

1. (1) These Regulations may be cited as the Immigration and Deportation (General) (Amendment) Regulations, 2020, and shall be read as one with the Immigration and Deportation (General) Regulations, 2011, in these Regulations referred to as the principal Regulations.

Title and commencement

(2) These Regulations shall come into operation on 1st January, 2021.

2. The principal Regulations are amended by the revocation of the Fourth Schedule and the substitution therefor of the Schedule set out in the Appendix.
