## The Technical Education, Vocational and Entrepreneurship Training (Establishment of Institutions and Constitution of Management Boards) (Amendment) Regulations, 2020

IN EXERCISE of the powers contained in sections 9 and 10 of the Technical Education, Vocational and Entrepreneurship Training Act, 1998, and in consultation with the Authority, the following Regulations are made:

1. These Regulations may be cited as the Technical Education,<br/>Vocational and Entrepreneurship Training (Establishment of<br/>Institutions and Constitution of Management Boards) (Amendment)<br/>Regulations, 2020 and shall be read as one with the Technical<br/>Education, Vocational Training (Establishment of Institutions and<br/>Constitution of Management Boards) Regulations 1999, in these<br/>Regulations referred to as the principal Regulations.S.I. 2. The Schedule to the principal Regulations is amended by the insertion of the following new paragraphs immediately after paragraph 22:
