The Ministerial and Parliamentary Offices (Emoluments) (Amendment) Regulations, 2021

IN EXERCISE of the powers contained in section 2 of the Ministerial and Parliamentary Offices (Emoluments) Act, and after consultation with the Standing Orders Committee of the National Assembly, the following Regulations are made:

1. (1) These Regulations may be cited as the Ministerial and Parliamentary Offices (Emoluments) (Amendment) Regulations, 2021, and shall be read as one with the Ministerial and Parliamentary Offices (Emoluments) Regulations, 2009, in these Regulations referred to as the principal Regulations.
