The Animal Health (Destruction of Pigs) (Compensation) Order, 2021

IN EXERCISE of the powers contained in section 69 of the Animal Health Act, 2010, the following Order is made:

- This Order may be cited as the Animal Health (Destruction)
- 1. This Order may be cited as the Animal Health (Destruction Title of Pigs) (Compensation) Order, 2021.
- 2. (1) An owner of a pig that was slaughtered and destroyed or otherwise disposed of prior to the commencement of this Order in order to control and eradicate the African Swine Fever outbreak in Luapula, Muchinga and Northern Provinces in 2017 and 2018, may claim compensation by submitting to the Director a claim in the form set out in the Schedule.

Claim for compensation

- (2) An owner of an imported pig is not entitled to claim compensation if that pig was already diseased or infected with the African Swine Fever at the time of its importation.
- 3. The rate of compensation payable for purposes of a claim under paragraph 2(1) is K250.00 for each pig slaughtered and destroyed or otherwise disposed of.
