The Immigration and Deportation (General) (Amendment) Regulations, 2021

IN EXERCISE of the powers contained in section 59 of the Immigration and Deportation Act, 2010, the following Regulations are made:

1. These Regulations may be cited as Immigration and Deportation (General) (Amendment) Regulations, 2021, and shall be read as one with the Immigration and Deportation (General) Regulations, 2011, in these Regulations referred to as the principal Regulations.
